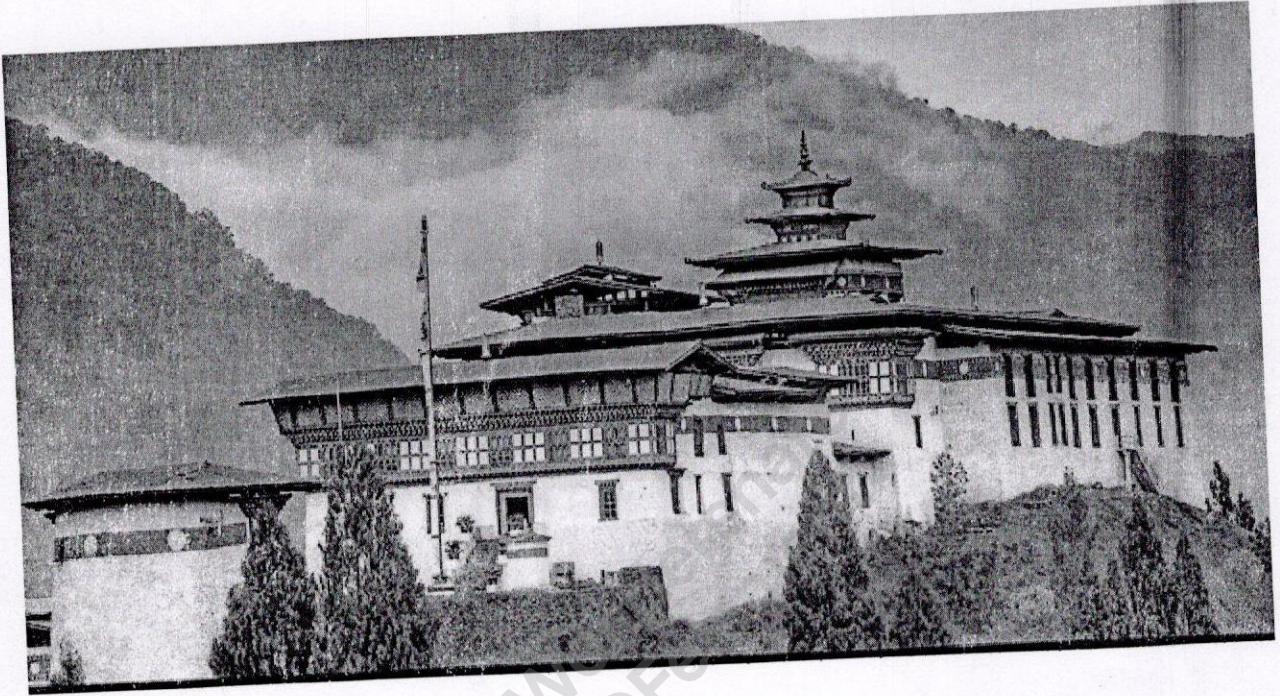

Terms and Condition

1. The base price for the auction is Nu. 167,775.00(One hundred Sixty Seven Thousand Seven Hundred Seventy Five) only. Based on the base price, you should quote your price. The highest bidder will be awarded to execute the work. If there is a tie in the highest bidder, the individual will be called to the Dzongkhag Administration for further way forward.
2. **The work shall include the following:**
 - I Demolition of two structures.
 - II. Stacking and lifting of demolished materials.
 - III. Clearing the debris of the area completely.
3. The work shall be completed within 20 days from the issuance of the work order. If the successful bidder fails to start the work and complete the work within given time, the earnest money shall be forfeited and the bidder will be terminated.
4. The committee from the Dzongkhag administration, Dagana shall carry proper handing taking after the completion of the work.
5. 70% of the quoted amount shall be paid to the dzongkhag administration at the start of the work and 30% after completion of the work.
6. The Earnest amount of Nu. 20000 (Twenty thousand) only should be deposited to Dzongkhag Administration, Dagana in the form of Cash Warrant or demand draft. It should be addressed to Dasho Dzongdag, Dagana. The earnest amount of the successful bidder will be retained till the completion of work and for unsuccessful bidders it will be refunded/released after awarding to the successful bidder.
7. It will be assumed that the interested parties bidding for the work have inspected the structure and bid offer is at their own liberty and judgment. No complaint will be entertained at a later date.

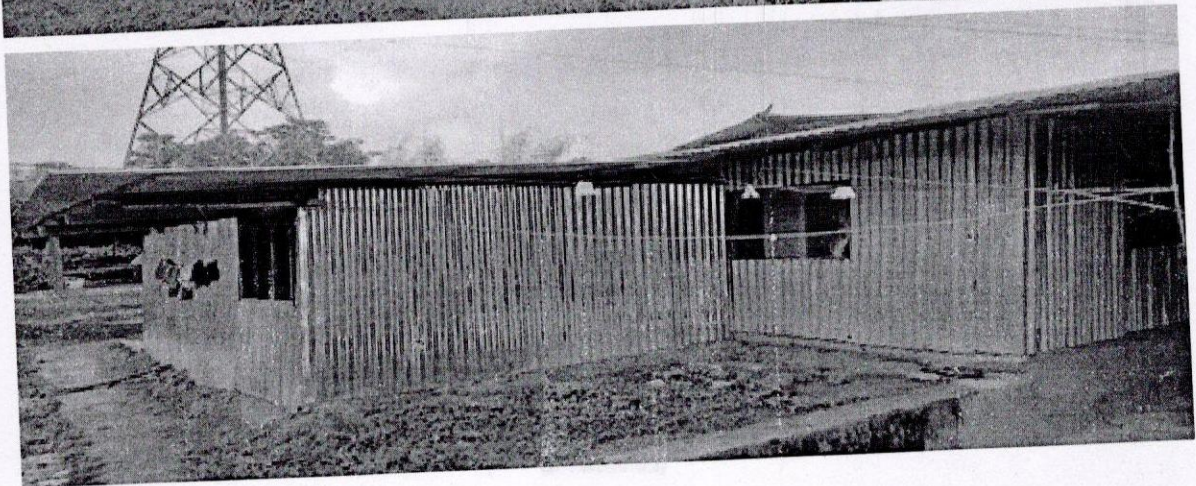
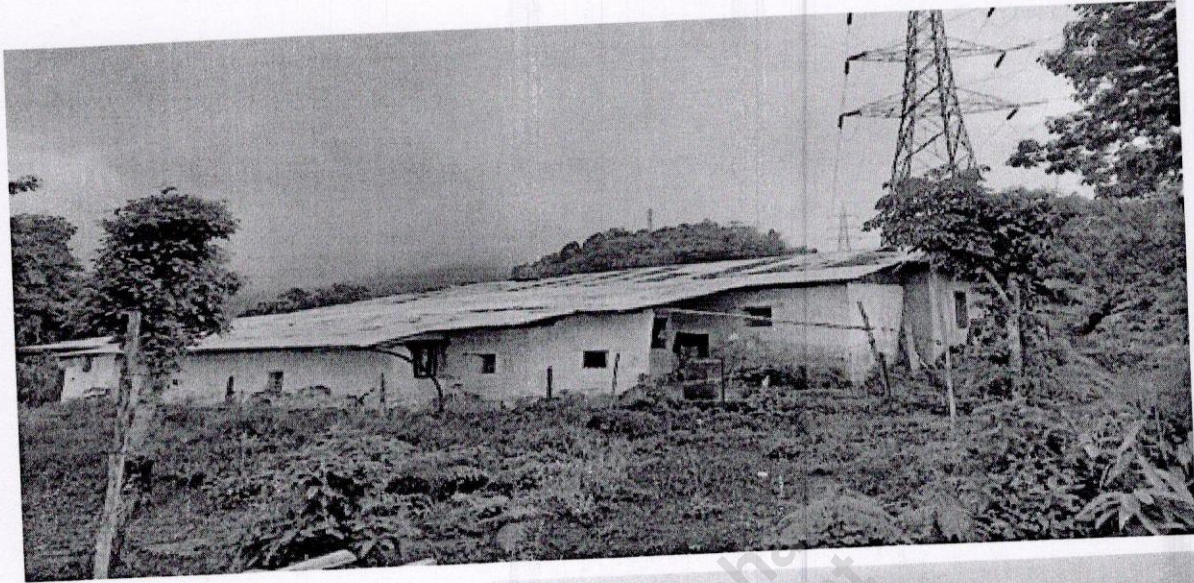
